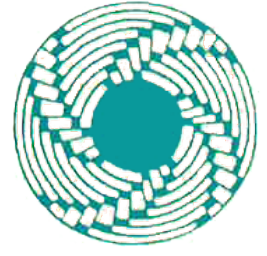

**Notice to Applicants:** Section 231 of the Crime Control Act of 1990, Public Law 101-647 (codified in 42 United States Code § 13041), and Section 408 of the Miscellaneous Indian Legislation, Public Law 101-630 (codified in 25 United States Code § 3207) requires a national criminal history records check as a condition of employment for positions that involve regular contact with or control over Indian children.

*All positions require an AZ Fingerprint Clearance Card & ability to successfully complete a Nat'l Criminal Background Check.*

### **Special Education Teacher- 200-Day Position**

Provides educational assistance to children with mental, psychological, learning, behavioral, or physical disabilities with the goal of facilitating the special education processes to maximize the growth potential of students with exceptional learning needs. **Requires** AZ ECE K-5 Teacher Certification with SPED Endorsement. Successful candidate must have ability to maintain effective working relationships with people of varied economic, educational and cultural backgrounds. Experience with Native American children and school systems preferred. **Salary DOE \$38,263 - \$58,083.**

### **Instructional Coach (K-5) – Year Round Position**

Works with classroom teachers to support student learning, provides professional development & personalized support based on goals & identified needs of teachers. **Requires** AZ State Cert. K-8 or K-12 with ECE and Master's degree preferred. Must meet NCLB/ESSA HQT requirements, and have 5 years classroom experience including Reading and Math as a major focus. Experience with Native American children and school systems preferred. **Salary DOE \$44,428 to \$59,538.**

### **Teachers - Kindergarten thru Grade 5 – 200-Day Position**

Requires Valid AZ Teacher Certification and Early Childhood Education Endorsement for Kindergarten. Experience with Native American children and school systems preferred. **Salary DOE \$38,263 - \$58,083.**

### **Substitute Teachers – On Call Position.**

Requires AZ State Substitute Teacher Cert. - **\$125 per day.**
