Face Coverings (Masks) are optional for all students and staff. These masks may be disposable or made of cloth. Masks must cover nose and mouth. Masks are provided daily to any student or staff member that requests.

Students are grouped in Cohorts. Cohort parameters are established by grade level. Staff and students will maintain a 3ft. minimum social distancing whenever possible. Although it may not be feasible at all times, employees and students will be reminded with announcements and signage.

Staff and students will be reminded to refrain from touching their faces, mouths and eyes, as well as to practice respiratory etiquette. Respiratory etiquette includes covering of coughs with a tissue and throwing the tissue away, sneezing into one's upper sleeve instead of one's hand and washing hands or using hand sanitizer. Staff and students will be reminded to wash or sanitize hands at the following times: after using the restroom, after using shared equipment before and after eating or preparing food, after blowing one's nose, coughing or sneezing. Proper handwashing signage is posted.

Frequently touched surfaces disinfected with a EPA disinfectant. All school building ventilation systems are operating properly and air filters are changed monthly. Every classroom and office space is equipped with an air purifier.

The school separates employees and students exhibiting Covid-19 symptoms immediately. If any person exhibiting Covid-19 like symptoms, he/she cannot leave campus immediately, he or she will go to a quarantine area with a supervisor or adult in line of sight. Staff working in the quarantine area wear proper PPE when taking care of the ill. Positive test results are reported to the Tribal Health Department for contact tracing.

COVID testing was offered bi-weekly to students and employees on site. As of SY 2023/24, we are no longer mandated to do so.

The school hosts quarterly vaccination clinics on site for the community. Staff members were provided vaccination by Tribal Health Care, free of charge.

Special accommodations, along with compliance of all state, federal and tribal laws, shall be made for students with disabilities or unique medical needs. Where possible, these students should wear mask and maintain a 3ft social distance. Staff will protect the privacy of those students at higher risk for severe illness regarding underlying medial conditions.

The school is committed to providing a high-quality educational experience for all students, while also helping to limit the spread of COVID-19. We are doing everything we can to minimize disruption to learning to ensure that students achieve academic success. Google Classroom is the platform utilized by the school to deliver virtual instructions if/when the campus is closed. Virtual after school intervention programs and tutoring will available to provide targeted instructional support. The school has provided individual laptop computers to all students and hot spots to those that need internet access.

As of now, we are in person and providing on-site instruction and after school tutoring.

29. How will the LEA ensure continuity of services for students' social, emotional, and mental health needs?*

The school has a full-time counselor that is available to meet students' social, emotional, and mental health needs and provide resources to students and families. The instructional block schedule allows for daily SEL lessons.

The school is contracted with Gila River Behavior Health for additional support.

For school employees, school has made available the EAP services provided by 3rd party.
