#### V. Presentation

a. St. Peter Indian Mission School Showcase Marcella Ortega, School Board President Opening of the newest addition to the school, opened after Christmas Break. The addition includes classrooms for grades Kindergarten to Third as well as a dedicated Science room. Students are working on their underwater robotics. The Gila River Fire Department was on site to fill the pool. Upcoming event is the Ira Hayes Parade; every year St. Peter parents and staff work in collaboration with the Ira Hayes Post to feed the Veterans and their families after the parade.

# VI. Reports

a. Governor's Education Summit Update

Mr. Thornburg gave a recap of the events that took place at Gila Crossing Community

School. There were approximately 340 participants. The keynote speaker was a Native

American astronaut, John Herrington. Mr. Thornburg noted that the event was successful.

The floor was opened for comments and concerns.

Donavan Kyyitan thanked TED for allowing Gila Crossing Community School to host this event. Some opinions that came from the elders were that the message that was delivered was geared more toward the kids. Serena Joaquin suggested that future summits should be broken down by grade. Another suggestion was to obtain donations of prizes for raffle for those educators who are non-Tribal.

After discussion it was suggested that a Committee be developed and start planning for next year. There was also the suggestion that Governor Lewis attend our next meeting to hear the ideas and concerns of the School Board Coalition.

#### b. Early Childhood Coalition

Jeff Thornburg- TED

Set up with the intention to understand all services available for children ages 0-5 years. Goals will be set from the upcoming Visioning Session. Location for work session is set at Governance center, all schools are invited. Visioning session location and date information will be forthcoming.

**Comments:** keep in mind the kids with disabilities. Issue of shortage of qualified teachers. Attention and inclusion of F.A.C.E program. Eligibility, or lack thereof, of child for head start.

c. K-12 Summer Bridge Program (8<sup>th</sup>- HS)

Tentative information: location at Sacaton School, 2-week duration (in June), half focus on education and half on social/ emotional expectations, tours of future schools, note-taking tips, testing strategies. This will be treated as a pilot program.

**Comments:** include information on how to link up with JOM counselors, if available, goal-setting tips, help buffer the "Culture shock" that our kids experience and time management.
